**ATP:**

Expressed their grievances on recent intra circle transfers, non-consideration of immunity and the prevailing adverse conditions in the BA. Requested the CEC to intervene and take-up the issue at circle level for their resolution.

**VZM:**

Expressed satisfaction on the intra circle transfers & slight worry on the out-going intra circle transferred members & requested to see that loss is compensated for balancing the strength with new in-comers. Submitted that Sri.B.Dharmasasta,SDE transfer case to be taken up by CEC. Promised to work for increasing the membership in the present drive

**ELR:**

Submitted that already 2 members joined officially and still efforts are kept for adding some more members by the end of the membership window. Requested CEC to work out for retention of Smt. P.Ashirvadamma,SDE for 6 months.

**VSK:**

Enquired the consideration of OTP requests still by the management. Requested to consider the posting of Sri.S,Jagapatireddy,SDE to Cellone-SKM. They are awaiting the intra circle transfers of JTOs to be released on 08.07.2024. Submitted that meetings are conducted for membership window drive.

**NLR:**

Requested CEC to consider the retention of Sri.G.Subrahmanyam,SDE for 6 months. Also requested support from CEC in postings of Chennai transferred members by coordinating with the Chennai AIGETOA CEC. Submitted that they are busy with the transfer issues and promise to work for increasing the membership in the present drive.

**VJW:**

He requested CEC to see that sufficient staff were posted for VJW for smooth roll-out of the ongoing projects and promise to work for increasing the membership in the present membership window.

**GTR:**

Expressed that the circle HR is giving transfers in a biased manner. All the incumbents are posted to circle office in spite of the pending OTP request transfers to circle office from GTR BA. DS requested CEC to follow up for early issuance of pending OTP request transfers and Modification/retention of Sri.G.Murali Krishna, SDE transfer case.

**CS Closing remarks:**

Expressed happiness over Intra circle transfer orders were issued. He urged the DEC members not to post any negative comments that would damage the sincere efforts of the CEC. He requested all the DEC members to share anything of that sort directly with him. He expected his optimism that all the genuine cases will be taken up sincerely & will be resolved.
