**Minutes of the Online meeting with CEC (Elected + Nominated), DP, DS, DFS, and Collegium members of AIGETO, AP Circle on 14.07.2024**

An Online meeting with CEC (Elected (11) + Nominated (29)), all DP, DS, DFS, and Collegium members of AIGETO AP Circle was conducted on 14.07.2024 @8 PM to discuss the following agenda points.

1. Discussion on pending Inter-Circle OTP Transfers and pending cases of Modification/Retention of inter-circle transfer orders.
2. Discussion on pending cases of modification/Retention of intra-circle longstanding transfer orders.
3. Review on the progress of the Membership drive.
4. Discussion on points to be presented in the proposed AIGETO CHQ AGM to be held on 08.08.2024 & 09.08.2024 at New Delhi.

### **Opening remarks by CS:**

In the opening remarks, CS, Sri. M V Satyanarayana requested all the members to share their efforts in adding new members to the membership drive. Requested to submit all representations w.r.t Inter Circle OTP pending/Modifications requests in their respective BA/OAs that were sent to CO-ND through proper channels for taking them with CHQ. He requested the members to submit the CHQ level issues to be raised or discussed in the coming CHQ, AGM. Also requested to share their views on the GHIS.

### **ATP:**

Added 2 members in the membership window. Requested to raise the concern of the pay loss issue of TTAs who got selected for JTO External Recruitment 2007 with CHQ. This is a 14-year-old pending case affecting as many as 500 members across India. Relief with the recent CAT verdict positively to the victims. Requested for retention of Y Gangadhar, SDE transfer. GHIS premium is to be borne by BSNL only. Due to inter circle transfer of DS,Sri Ramasubba Reddy,.CS requested DEC for immediate arrangement for an alternative.

### **NLR:**

Added 3 members in the membership window. Conducted desk-to-desk campaign targeting the accounts members. Expressed satisfaction with the Intra-Circle transfers. Requested CEC for retention of transfer case of Sri.G.Subrahmanyam,SDE. Requested for extension of pension facility to the TTAs who recruited on DOT notification is to be taken up with CHQ in the scheduled AIGETOA AGM. This would benefit as many as 2000 members across India.

### **GTR:**

Added 2 members in the membership window & expecting another 1 addition. Trying for another 2 additions. They conducted the campaign by contacting the members over the phone. Requested for the retention of G.Srinivasarao, SDE transfer case to Assam and pursuance of inter circle transfer case of K.N.V. Prasanna Kumar,SDE. All the incumbents are posted to the circle office despite the pending OTP request transfers from GTR BA. Raised concern on the retention of Sri. G. Murali Krishna, SDE transfer. CS assured to take up for retention. The GHIS 3 children useless as most of the members have only 2 children. This would increase the premium unnecessarily. May be changed to 2 children & 2 parents. Reminded the GS, AIGETOA assurance of SAB increment during his visit to Vijayawada and raised concern on pay loss issue of TTA to JTO Promotees and requested to take up with CHQ.

**VZM:**

Expecting 2 members in the membership window. Requested .B.Dharmasasta, SDE transfer case from SKL to VZM to be taken up by CEC. Submitted that there are no issues related to Inter circle transfers.

**VSK:**

Expressed that the status of the membership window depends on the 60 local transfers in VSK. Because of the prevailing unrest among the transferred members, one member left AOGETOA membership. Expecting one addition in the membership window. Regarding GHIS, the premium is very high & should be borne by BSNL only. Single parent option to be incorporated. Requested BA share of association fund.

**CHT:**

Submitted that they conducted the campaign by contacting the members over the phone. Added 2 members in the membership window & expect another 2 additions. Regarding GHIS, the premium should be borne by BSNL only.

**KNL:**

Added 1 member in the membership window & expect another 2-3 additions. They are in regular in-touch with all the members in the membership drive. Regarding GHIS, the premium is very high & should be borne by BSNL only. Also, the option of MRS without vouchers as earlier implemented may be re-introduced.

**RMY:**

Added 2 member in the membership window & expect another 3 additions. Long standing list of SDE and JTO BA wise should be displayed. Regarding GHIS, the premium is very high & should be borne by BSNL only.

**ELR:**

Added 3 members in the membership window & expect another 2-3 additions. Requested CEC to work out for retention of intra circle transferred cases of Smt. P.Ashirvadamma,SDE and A.Rajkumar,JTO. GHIS should be continued without any breaks as it would affect the members & their families during the break period.

**VJW:**

Added 2 members in the membership window & expect another 2 additions. Conducted DEC with 8 members during the membership window drive. Requested for modification of Intra-Circle transfer case of Sri V.S.Pandurangaraju from GTR BA to ELR BA or at least try for his retention and modification of Inter-circle transfer case of Smt. Chandrakala from Chennai to Telangana or retention in AP Circle.

**CNTX-S:**

Thanked the CS for forming a new CNTX-S body. Submitted that they are in touch with all the members. Requested for posting of Sri. Jayaram to KNL CNTX-S who is going to join in AP circle on Rule-8 transfer from KTK to AP Circle.

**CS Closing remarks:**

Expressed happiness over Intra circle transfer orders were issued. All the officer bearers at Circle & District level are working voluntarily for the welfare of the members & association. There might be some issues related to transfers in the challenging BAs like VJW, GTR, and ATP.

Questioning & cornering the management will not give fruitful results. He urged the DEC members not to post any negative comments that would damage the sincere efforts of the CEC and DEC. He requested all the DEC members to share anything directly with him. He assured that all the genuine cases will be taken up sincerely with the management & will be resolved. Only time is a constraint. He asked the members to be patient. BA quota subscription details will be submitted in next meeting. The DEC members should be strong & should be in touch with all the members to infuse faith & trust in the association. The association at Circle & District level should deal amicably with the management for fruitful solutions to address the issues.

The meeting ended with a vote of thanks by Sri. K.Ravi Kumar, CFS, AP Circle .
