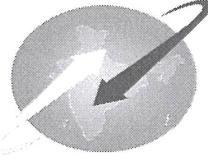

NOTIFICATION

Sub: Grant of Status (i) “Recognised Representative Association” (ii) “ Support Association” on the basis of 3rd Membership Verification of Executives’ Association in BSNL.

The 3rd Membership Verification process was conducted as per Bharat Sanchar Nigam Limited (Recognition of Executives’ Association) Rules, 2014 for which polling was held on 12.09.2023.

2. As per the result of 3rd Membership Verification declared by Chief Returning Officer vide his letter No.CRO/BSNL/MV/2023 dated 14.09.2023 following position emerged:

| S.No. | Name of Association | No. of Votes | %age of total votes secured | Position |
|-------|---------------------|--------------|-----------------------------|----------|
| 1. | SNEA | 15020 | 52.07 | First |
| 2. | AIGETOA | 10028 | 34.76 | Second |

3. In terms of Rule 3(1) of the said Rules, *BSNL shall have only one representative association of executives which gets majority votes in the Membership Verification subject to a minimum of 35% membership of total votes of the working executives in BSNL.*

Accordingly, “Sanchar Nigam Executives Association”, which secured majority votes and also more than 35% votes, shall be the “ Recognised Representative Association” and is given the status of the “Majority Recognised Association” at Corporate level, all Circles and BA level.


4. Further, in terms of Rule 3(2) of the said Rules, *any participating association other than majority representative association, which gets second majority votes and not less than 15% votes of the total working executives in BSNL, will be given the status of a "Support Association"*.

Accordingly "All India Graduate Engineers & Telecom Officers Association", which secured second majority votes and also more than 15% votes, shall be the "Support Association" and is given status of the "Support Association" at Corporate, all Circles and BA level.

5. The period of recognition of the "Recognised Representative Association" and "Support Association" shall be for a period of THREE years from the date of this Notification i.e. from 25.09.2023 to 24.09.2026.

6. The facilities, "Recognised Representative Association" and "Support Association" are entitled to, as per Rule-10 and Rule-10(A) of BSNL (REA) Rules, 2014 respectively shall be extended at all levels i.e., Corporate, Circle and BA. The facility of special casual leave to "Support Association" shall be granted as per SR Cell letter No. BSNL/31-2/SR2016 dated 18.07.2017.
